SEP 21 **ARRIVAL IN MALDIVES** **(Inflight Meals)**

Upon arrival in Maldives, the group will be transferred to the city hotel where you will spend the next 2 nights.

Accommodation: Jen by Shangrila Male **(2 Nights)**

SEP 22 **MALE CITY TOUR** **(B/L)**

After breakfast, we will start a walking city tour including the main square **Jumhooree Maidan** where a huge Maldivian flag flies. Good walkers can go see the brand new China-Maldives friendship bridge, called **Sinamalé Bridge**, 2.1 km long and inaugurated on August 30, 2018.

Visit the **Rasrani Bageecha**, formerly known as the Sultan's Park, and housing antiquities from the Maldives' Buddhist era to Muslim rulers.

SEP 23 **TRANSFER TO BEACH RESORT** **(B/L/D)**

After checking out from your city hotel, you will board your speedboat transfer to OBLU Experience Ailafushi where you will spend the next 2 nights.

The stay in the resort is all-inclusive in a water villa.

Accommodation: OBLU Experience Ailafushi **(2 Nights)**

SEP 24 **FREE AT LEISURE** **(B/L/D)**

The day is free for the group to spend at their own leisure.

SEP 25 **MALDIVES – BALI** **(B)**

Today, you continue your trip to Bali.

Upon arrival, Upon arrival in Bali (Ngurah Rai Airport), we meet our guide and travel to your hotel. Hotel standard check in time is after 2:00 pm. Early check in available with a surcharge.

Accommodation: Kappa Senses **(3 Nights)**

SEP 26 ENCHANTING UBUD TOUR (B/L)

Spend a full day exploring the best of Ubud, Bali's cultural heart, and discover inspiring views, waterfall, and cheeky wildlife.

The first stop is at **Tegenungan Waterfall**, Tegenungan waterfall, it is one of the most visited waterfalls near Ubud. Tegenungan Waterfall is located around 15 minutes away from the center of Ubud. It is one of Bali's largest waterfalls and more than an impressive sight.

Drive further north to the iconic **rice terraces of Tegallalang**, where lush green paddies create a stunning patchwork on the side of the hills and take a short walk through the intricately designed terraces. Next visit **Ubud Palace**, the home of the local royal family standing in the heart of the town. Take a walk through the nearby **Ubud Market** among the colorful stalls of wood carvings, textiles and souvenirs.

After lunch, visit **Ubud Monkey Forest**, a sanctuary for the malevolent but photogenic long tail macaques. Walk through the forest and temple where mischievous monkeys roam freely. On the far side of the forest, the car will be waiting to drive you back to the hotel.

Time: approx. 08:30-17:00

SEP 27 MUNDUK COFFEE & WATERFALL TOUR (B/L)

Drive to **Munduk village** located in a remote area of Bali. On the way pass through Bedugul, a lush green area of fruit and vegetable fields, with its winding road. As you approach Munduk, make a stop to photograph **Buyan and Tamblingan**, two serene lakes situated in old volcanic craters surrounded by untouched nature. After passing the greenery, leave the vehicle and set off on foot.

Visit a **coffee plantation**, take a walk and see how coffee is produced using natural techniques by local farmer. Munduk is blessed with fertile soil and perfect for coffee and other plantation such as clove. The local farmers here produce coffee from generation to generation and still maintain the traditional process until now. After enjoying a coffee drink, we continue to visit one of the many waterfalls in the area. The trek to **waterfall** could be exhausting but the reward is worth. Cool off with a dip in the pool, or sit on the edge and soak your feet.

Lunch will be served at local restaurant, and after that return to the hotel.

Time: 08:00 - 17:00

Notes: The walk to waterfall is about 1 hour per way. The water level depends on season. Bring hat, sunglasses, sunscreen, swimwear and towel, wear shoes/trekking sandal. Walk path is slippery in rainy season, so can be skipped depending on weather and replaced by other visit on the way.

SEP 28 BALI – DUBAI (B)

After breakfast, the group will be transferred to the airport for your flight home but before that, the group will stop in Dubai for a few days.

On arrival, and after finishing the immigration formalities, baggage claim, and customs, our professional representative will be waiting at the meeting hall to warmly welcome you and escort you to your vehicle. Transfer afterward to your hotel in Dubai.

SEP 29 TRADITIONAL & MODERN DUBAI (B)

Abra Ride (Water Taxi): Board one of the traditional local Abras (Water taxi) which is used till today to cross the Dubai creek

Dune bashing has become known as a fun experience – You will feel the thrill of desert driving as your professional driver takes you up and down on golden dunes. A beautiful photo stop on top of the dune is also included before arrival at the Bedouin camp. No Bedouin experience is complete without a traditional cup of Arabic coffee and a camel ride. This is followed by a typical barbeque dinner, prepared on the open fire, and of course, a magical belly dancing show to complete the evening.

This amount will be deducted from the final invoice. If the group cancels, we will hold on file the initial deposit for up to 1 year to be transferred once to a future new group booking; sorry it cannot be transferred to an existing group and/or a new or existing FIT booking.

Prices cannot be confirmed until all land and/or air arrangements have been booked as per the group's final itinerary.

Maldives: A Visa on Arrival is required.

Indonesia: A Visa is on arrival is required.

VOA-Visa on Arrival cost remains at IDR 500.000 per person (applies to adults and children). VOA-Visa on Arrival is for a single Entry into Bali/Indonesia, for a stay up to 30 days and can be extended for a maximum 1 time at the local Immigration Office (charges apply)

Payment can be done by: VISA Card, Master Card or Debit Card Cash in IDR or foreign currency USD, EURO, GBP, SGD and others as per set exchange at the airport counter inside the terminal.

E-VOA

It is now possible to apply online up to up to 14 days before arrival via the following website: <https://molina.imigrasi.go.id/>

E-VOA is a single-entry visa which is valid for a stay up to 30 days and can be extended for a maximum 1 time at the local Immigration Office (charges apply)

Arriving in possess of the e-visa allows to queue directly for the passport stamping, skipping the line to purchase the VOA- Visa on Arrival.

IMPORTANT NOTE: Starting on 14 February 2024, Bali will implement a new tourist entrance fee of IDR 150,000 or approx. USD 10 per person for foreign visitors, including children. This fee will be charged directly to visitors on arrival, by cash or credit card, and it is in addition to the existing Visa on Arrival (VOA) fee of IDR 500,000.

UAE: At this time of quotation, a VISA is not required.

HEALTH INFORMATION:

- I. **COVID:** Your travel arrangements could still be impacted by COVID.
